TRANSFER OF REGISTRATION FOR PURPOSES OF THE BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS

Filipino Overseas Voters who intend to participate in the upcoming Barangay and Sangguniang Kabataan (SK) elections are advised that they may file an application for transfer of their registration records from the Philippine Consulate General in Chicago to the concerned local registry of the city/municipality in the Philippines.

The Commission on Elections (COMELEC) promulgated the procedures on the transfer of overseas registration records through Resolution No. 10152 dated 15 July 2016. In line with this, the period set for the filing of application for the transfer of registration records is from **15 to 30 July 2016 only**.

Applicants for transfer shall accomplish the required form (OVF No. 1-B), attached to this advisory, and file the same in two (2) copies with one of the following:

- a) Office for Overseas Voting (OFOV)
7th Floor, Palacio del Gobernador Building
Intramuros, Manila
- b) Office of the Election Officer (OEO)
in the applicant's city/municipality in the Philippines
- c) Philippine Consulate General

Chicago, IL 60603

Applications received by the Consulate will be immediately transmitted to OFOV for consideration and approval. The Consulate will, in turn, be informed of the action of the Commissioner-in-charge of OFOV on the application for transfer.

Overseas voters will not be allowed to apply for transfer of registration to any local registry of the city/municipality other than their place of residence as indicated in their overseas registration records or in the local Certified List of Voters. **END**
