## ADVISORY ON DEACTIVATION OF OVERSEAS VOTERS

The Resident Election Registration Board of the Commission on Elections has issued the Order of Deactivation dated 8 November 2019 which orders the deactivation of 313,101 overseas voters who failed to vote in the 2016 and 2019 National and Local Elections.

A total of 2,748 overseas voters in the U.S. Midwest were removed from the overseas database of the Philippine Consulate General in Chicago. Please visit <http://chicagopcg.com/> to view the list of deactivated voters.

To verify the status of your registration, overseas voters registered with the Philippine Consulate General in Chicago are requested to contact the Overseas Voting Section of the Consulate through email [ovchicagopcg@gmail.com](mailto:ovchicagopcg@gmail.com). Please attach a scanned copy of your valid Philippine passport for identification purposes.

Deactivated overseas voters need to file their application for registration at the nearest embassy/consulate or other registration centers authorized by the Commission on Elections to be able to participate in the 2022 National Elections. Filing of applications for registration shall be from December 16, 2019 to September 30, 2021.

The Philippine Consulate General in Chicago has jurisdiction over the following Midwest States: Illinois, Indiana, Iowa, Kansas, Michigan, Minnesota, Missouri, Nebraska, North Dakota, Ohio, South Dakota, and Wisconsin. To register, all applicants must personally appear at the following address for biometrics capture:

Applicants must bring the following requirements: 1) photocopy of valid passport; and 2) additional proof of Philippine citizenship, i.e., valid Permanent Resident (green) card, valid visa, Notice of Action or, if dual citizen, copy of Dual Identification Certificate and Oath of Allegiance.

Filipino citizens residing in Arkansas, Louisiana, Mississippi and Oklahoma – states that were previously under the jurisdiction of the Philippine Consulate General in Chicago, but are now under the purview of the Philippine Consulate General in Houston – may now register at the following address:
