REQUIREMENTS FOR RENUNCIATION OF CITIZENSHIP

1. Applicant must be at least 18 years old
2. Affidavit of Renunciation of Citizenship – one original and two photocopies
3. Philippine passport – original and three photocopies
4. For dual citizens under R.A. 9225, submit Oath of Allegiance, Identification Certificate and Order of Approval – original and two photocopies
5. Birth Certificate/ Report of Birth – original and three photocopies
6. U.S. Passport/ Driver's License/ State ID - original and three photocopies
7. For those born in the United States, submit proof of Philippine citizenship of parent/s at the time of birth (e.g. US Naturalization Certificate, Philippine passport, green card)
8. Fee of \$50.00 in cash or money order
9. pre-paid return envelope with tracking number (e.g. Priority Mail, Express Mail, UPS)
