REPORT OF DEATH REQUIREMENTS
(To be accomplished only if the deceased was a Filipino citizen)

1. Request signed by the next-of-kin (NOK) with attached proof of NOK status (copy of Marriage Contract or Birth Certificate). Please indicate your contact details (mobile no. and email address).
2. Five (5) original duly-accomplished **REPORT OF DEATH** (ROD) forms, TYPEWRITTEN, signed by the NOK/ Informant and notarized by a local notary
3. One (1) original or certified true copy (CTC) and five (5) photocopies of the **Death Certificate** (original/ CTC will be returned)
4. Five (5) photocopies of **proof of Philippine citizenship** of the deceased (Philippine passport, green card or Identification Certificate for dual citizens)
5. Two (2) originals and three (3) photocopies of notarized (by a local notary) AFFIDAVIT OF DELAYED REGISTRATION (Form is enclosed) explaining the reason/s for delayed registration if ROD is filed more than a year after the date of death
6. Send the above-mentioned requirements by mail to the Philippine Consulate General (122 S Michigan Ave., Suite 1600, Chicago, IL 60603). Include a self-addressed return envelope (with appropriate stamps for express or priority mail with tracking numbers via US Postal Service, or with pre-paid mailing envelope from a private courier of choice **[except FedEx]**), and a non-refundable processing fee of \$25.00 (money order payable to "Philippine Consulate General"). **Personal checks and credit cards are not accepted.**
