



CONSULATE GENERAL OF THE REPUBLIC OF THE PHILIPPINES CHICAGO

EXEMPTION FROM THE TEMPORARY SUSPENSION OF VISA-FREE PRIVILEGES

With reference to Inter-Agency Task Force on Emerging Infectious Diseases [Resolution No. 85](#) dated 26 November 2020 and Republic Act No. 6768, as amended, starting **7 December 2020**, the following shall be allowed visa-free entry to the Philippines

1. **Filipino Citizens' foreign spouses and children, regardless of age, who are travelling with them; and**
2. **Former Filipino citizens together with their foreign spouses and children, regardless of age, who are travelling with them;**

The entry of the aforementioned nationals will be subject to the following conditions:

1. **They must be nationals permitted/allowed to enter the country visa free under *Executive Order No. 408 and 1960*:**
2. **They must have a pre-booked [quarantine facility](#);**
3. **They must pre-booked COVID-19 testing at a laboratory operating at the airport and**
4. **They are subject to the maximum capacity of inbound passenger at the port entry during the date of entry.**

The entry of the above-mentioned foreign nationals shall be subject to the implementing [guidelines](#) by the Bureau of Immigration.

Other *foreign spouses and children of Filipino nationals who do not belong to the aforementioned categories shall remain subject to existing travel restrictions.* For inquiries, you may email the Visa Section at chicagopcq.visa@att.net.
