**INVITATION TO BID**

The Consulate General of the Philippines in Chicago, Illinois, USA, invites bids for the sale of one (01) used unit Mercedes Benz E350, 4-door Sedan, 2011, Black, at a minimum selling price of **Four Thousand Eight Hundred Forty Seven US Dollars (US\$4,847.00)**.

Interested bidders are required to submit to the Consulate, in a sealed envelope, three (3) copies of Auction Tender form (Annex A), duly accomplished and signed, on or before **4:00 p.m. of 13 January 2026**. Furthermore, interested bidders are required to pay an auction bond equivalent to 10% of the minimum bidding price, in the form of **Cash, Money Order or Cashier's Check payable to "Consulate General of the Philippines in Chicago"** which shall be considered as partial payment of the winning bidder. Auction bonds of non-winning bidders shall be returned after the announcement of the winning bidder.

Subsequently, **the opening of the sealed bids is scheduled on 13 January 2026 at 5:00 p.m.** at the below-mentioned address in the presence of the Chair and members of the Disposal Committee of the Consulate and interested bidders to determine the winning bidder.

Photos of the said vehicle are found in Annex B. **The vehicle is being sold as-is, where-is, with no return policy. This is a tax-exempt vehicle; hence, all applicable taxes shall be borne by the winning bidder upon registration as the new legal owner of the vehicle.**
