OUTREACH ANNOUNCEMENT

CONSULAR OUTREACH MISSION Indianapolis, Indiana 11 December 2021

The Philippine Consulate General in Chicago informs the Filipino and Filipino-American communities that it will conduct an outreach mission for passport and dual citizenship services at the Philippines Cultural Community Center, 4141 S East St., Indianapolis, IN 46227 on 11 December 2021, a Saturday.

In view of the current health protocols due to the COVID-19 situation, the event will be strictly by appointment only (No "Walk-ins"). Only 160 passport applicants (20 per hour) will be accommodated during the event and 80 applicants for dual citizenship (20 per schedule).

Please note that applicants with confirmed appointments (via email) will only be allowed entry into the venue a few minutes before their appointment.

For specific instructions, please read below:

PASSPORT

1. **Send an email-request for appointment with the full name of the applicant (subject: Indiana December 2021) to: cpcgin.passport@gmail.com.** Send one email per applicant (except for immediate family members).
2. The Consulate will confirm appointment and provide appointment time by email. Please proceed to the venue a few minutes before your appointment and bring an accomplished Application Form and complete requirements, including a self-addressed envelope (one envelope per applicant, preferably a USPS Priority Mail or UPS Prepaid envelope, with stamps and tracking number) **except FEDEX**.

For the Application Form and the list of requirements, visit: www.chicagopcg.com/forms_eppt.html. Please note that there will be no photocopy services at the venue.

3. Only applicants with confirmed appointments will be allowed entry into the venue. Companions will only be allowed for minors, senior citizens or persons with disability (one companion per applicant).
4. Bring your own pen, wear a facemask during the event, and submit a health declaration at the entrance. Your temperature will be checked before entry into the venue,

DUAL CITIZENSHIP

1. Send an email-request for appointment with the full name of the applicant (subject: Indiana December 2021) and copies of requirements (visit: www.chicagopcg.com/dual.html) to: cpcgin.dual@gmail.com (form and requirements in one pdf file). Send one email per applicant (minor family members should be included in one email).

Initial email-requests will only be accepted until 29 November 2021.

2. Once the application/request is pre-approved (notification will be sent by email), physical copies of the requirements (not originals) should be mailed to the Consulate before 03 December 2021. Late submissions will not be accommodated.
3. The Consulate will confirm appointment and provide appointment time by email. Please proceed to the venue a few minutes before your appointment and bring complete requirements. *Please note that there will be no photocopy services at the venue.*
4. Only applicants with confirmed appointments will be allowed entry into the venue. Companions will only be allowed for senior citizens or persons with disability (one companion per applicant). Due to limited slots, dual citizenship applicants will not be processed for passport services.
5. Bring your own pen, wear a facemask during the event, and submit a health declaration at the entrance. Your temperature will be checked before entry into the venue,
